

**ORDINANCE NO. 07-10**

**AN ORDINANCE ADOPTING PREVAILING RATE OF WAGES  
FOR PUBLIC WORKS**

WHEREAS, the State of Illinois has enacted the “Prevailing Wage Act” approved June 26, 1941, as amended; and

WHEREAS, the Prevailing Wage Act requires that the Village of Somonauk investigate and ascertain the prevailing rate of wages for laborers, mechanics and other workers employed in any public works or under contract for public works for the Village.

NOW THEREFORE, be it resolved by the Board of Trustees of the Village of Somonauk, DeKalb and LaSalle Counties, as follows:

**SECTION 1:**

To the extent and as required by the Prevailing Wage Act, the general prevailing rate of wages for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Village of Somonauk is hereby ascertained to be the same as the prevailing rate of wages for construction work in the DeKalb and LaSalle County areas as determined by the Illinois Department of Labor as of July, 2007. A copy of said determination is attached hereto as Exhibit “A” and is incorporated by reference herein.

**SECTION 2:**

Nothing herein contained should be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment, except public works construction of the Village of Somonauk to the extent required by the aforesaid Prevailing Wage Act.

**SECTION 3:**

The Village of Somonauk shall publicly post or keep available for inspection by any interested party this ordinance as determination of such prevailing wage rate.

**SECTION 4:**

The Village of Somonauk shall mail a copy of this Ordinance to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages would be affected by such rates.

**SECTION 5:**

The Village of Somonauk shall promptly file a certified copy of this Ordinance with the Illinois Secretary of State, Springfield office.

**SECTION 6:**

The Village of Somonauk shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
