

ORDINANCE NO. 07-26

**AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CORPORATE LIMITS OF THE
VILLAGE OF SOMONAUK,
DEKALB AND LASALLE COUNTIES, ILLINOIS
(Somonauk Property)**

WHEREAS, the Village of Somonauk, as the owner of certain property, desires that said property be annexed to the Village of Somonauk;

WHEREAS, the territory sought to be annexed to the Village of Somonauk is contiguous to the existing corporate limits of the Village; and

WHEREAS, the territory sought to be annexed is not within the corporate limits of any municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SOMONAUK, DEKALB AND LASALLE COUNTIES, AS FOLLOWS:

SECTION 1.

The following described territory be and the same is hereby annexed to the Village of Somonauk, an Illinois municipal corporation, DeKalb and LaSalle Counties, Illinois.

SECTION 2.

The Village Clerk shall record a copy of this Ordinance at the Office of the LaSalle County Recorder of Deeds and filed certified copies of this Ordinance in the Office of the LaSalle County Clerk within the time required by law.

SECTION 3. SEVERABILITY

This Ordinance and every provision thereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs and provisions and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with any of the provisions of this Ordinance shall be, and the same are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
